

***Minutes of meeting of the Executive Committee held on 12<sup>th</sup> December 2015 at Chamber House under the Presidentship of Sh. Rakesh Gupta.***

*At the outset Secretary General, Sh. Arun Gupta welcomed the members and also informed the members about the sad demise of some Sr. Members of Executive Committee during the interim period. The house observed two minutes silence to condole their demise.*

*While taking up the agenda of the meeting the house unanimously confirmed the minutes of the last meeting of the Executive Committee held on 12<sup>th</sup> December 2014 at Chamber House.*

*Thereafter Sh. Arun Gupta, Secretary General Chamber of Commerce & Industry placed before the house the report on the interim activities.*

*While taking up the agenda point regarding Extension and renovation of the existing Meeting Hall on the ground floor for discussions, Sh. Rakesh Gupta, President apprised the members about the need to extend and renovate the existing Meeting hall on the ground floor and also to utilize the space adjacent to the said meeting hall. *while expressing his views said that the space proposed to be clubbed with the meeting hall is basically meant for installing the lift as there is no any other suitable place that has better access to the upper portion of the building.*

*Another Sr. Member Sh. Sahab Saroop Gupta expressed that even after the extension of the existing meeting hall, the lift is to be installed at the same place because No other space is available where the lift can be installed. Majority of the members were of the view that the existing meeting hall should be extended and renovated to accommodated more members and after thorough discussions the point was carried through by the house and authorized the office bearers to proceed further in this regard.*
